Guidelines

Click each link in the table below and follow the instructions on every website. You may need to sign up using an e-mail address or phone number to create an opt-out request. Some sites will require faxing documents or uploading an image of yourself to process the request. If you've had multiple names in the past, we recommend checking for prior names as well. It is possible that some of the websites below will not have your information and you can skip them.

Every six-to-twelve months, we recommend rechecking the list of data broker websites to confirm that your information has not resurfaced. You may want to check more frequently if you move, have a new public record (such as a court judgment), or have children. For those in public safety positions, checking these websites after critical incidents can help protect your information from leaking to the press or unwanted hands.

Please note, it is an ongoing process to collect and gather every data broker website we can find. We are not responsible for websites that change their opt-out process, or change their opt-out URL after the creation date of this document.

Beyond personal safety, maintaining privacy can also help reduce operational risks. Criminal suspects, hostile individuals, or activist groups may attempt to use personal information to intimidate, manipulate, or discredit officers and departments. In high-profile cases or contentious environments, even routine actions can lead to outsized scrutiny—making it even more important to proactively limit what information is available about you online.

Whether you're a patrol officer, detective, investigator, or part of command staff, this manual provides actionable steps to protect yourself and your loved ones. It also includes tips on maintaining long-term privacy habits, securing digital accounts, and understanding the legal rights you may have to request data removal.

Taking the time to follow this guide is an investment in your security, your career, and your peace of mind.

Part 1: General Privacy Principles

Use Alternate Contact Information

- Use a PO box or your law enforcement agency address instead of your home address for licenses, vehicle registration, and memberships.
- Get a separate phone number (e.g., Google Voice or a secondary SIM).

Lock Down Social Media

- Set all profiles to private.
- Use aliases or middle names where possible.
- Never post your location in real-time.

Strong Password Hygiene

- Use unique passwords for every account.
- Enable two-factor authentication.
- Use a trusted password manager (e.g., Bitwarden, 1Password).

Part 2: Opting Out of Data Broker Sites

What Are Data Brokers?

These are companies that collect and sell personal data, including home addresses, phone numbers, and relatives' names. Examples include Whitepages, Spokeo, and Intelius.

How to Opt Out

- Search for yourself using your full name and location.
- Note any variations (middle name, former addresses).
- Use each site's opt-out form. Most require ID verification.
- Use a redacted ID copy (address blocked out) when necessary.

Listed in no particular order. The average time to complete each one is approximately two minutes.

Part 3: Google and Search Engines

Remove Yourself from Google Search

- Go to: [Google Content Removal Tool](#)
- Request the removal of:
 - Doxxing content (home address, phone number).
 - Outdated or inaccurate results.

Suppress Personal Info in Google Maps

- If your home appears in Street View:
 - Go to Google Maps, find your home.
 - Click "Report a problem" and request blurring.

Part 4: DMV & Voter Records

Driver Privacy Protection Act (DPPA)

- Contact your state DMV and request address privacy if you're in law enforcement. For Nevada peace officers and support staff please use this form: <https://dmv.nv.gov/pdfforms/dmv007.pdf>.

Voter Registration

- In some states, officers can request to make their voter registration info confidential. In Nevada, the form is located here (but it requires a court order):

Part 5: Real Estate Records

Protecting Your Home Address

- Consider creating a trust or LLC to purchase property under a name that doesn't trace back to you.
- Ask your county clerk about suppressing deed/address records if allowed.

Part 6: Alerts and Monitoring

Set Up Google Alerts

- Go to Google Alerts and create alerts for:
 - Your full name
 - Your address
 - Any aliases

Monitor Data Breaches

- Use services like HaveIBeenPwned.com to check for compromised emails.
- Consider credit monitoring (especially if your SSN has been leaked).

Final Tips

- Repeat opt-outs every 6–12 months—many sites repopulate data.
- Be consistent with your online identity. Use the same alias across platforms.
- Be cautious about third-party apps and online quizzes—they harvest data.
- If anything looks suspicious, stick to your guts and avoid it.
